The response on the part of Ardsley Curling Club members and members of other Grand National clubs to the Iceless Bonspiel to be held at Manchester, Vermont on October first has been so enthusiastic that definite plans are now being made.

As you know, Ardsley acted as hosts at the Iceless in 1948 and we have again been given that honor for the 1949 Bonspiel. This enables us to, in part, repay the many years of hospitality we have enjoyed at these functions.

It entails the direction of the arrangements and committees to handle the details will be appointed by Eddie Fiske who is chairman of the over-all Committee, assisted by Harold Sothern as vice chairman. When we have definite information as to those who will attend, Eddie will make committee assignments which we hope you will fulfill.

You will recall that last year we donated the Ardsley cup for competition at the Iceless which stays in competition as a team prize. In addition, we will be responsible for supplying three individual medals for curlers. Farmington has donated a prize for the curling widows. We will also be hosts at a cocktail party, prior to the curling dinner on Saturday night.

In order that we may make definite arrangements with the Equinox House, it is requested that all those who plan to attend forward the enclosed postal card to Eddie Fiske at once. A closing date of September 15th for reservations is necessary.

Rates at the Equinox House are as follows:

\$12.00 per day per person American Plan for double room, twin beds and private bath

\$14.00 per day per person American Plan for single room with private bath

\$13.00 per day per person American Plan for single room with connecting bath

\$10.00 per day per person American Plan for double room with connecting bath

If you do not plan to bring your wife, efforts will be made to put two Ardsley members in a double room, unless you request otherwise.

The Equinox House operates under the American Plan and arrivals on Friday afternoon in time for dinner and departures Sunday after luncheon would represent two full days from the rate standpoint.

All of those attending the Iceless are urged to bring their Ardsley Curling jackets for the Saturday night dinner.

Your officers have no need to tell you what a beautiful golf layout awaits you at Manchester and from your earlier response when this location was first broached, are sure that there will be a large turnout of Ardsley Curlers, as well as from all other clubs in the Grand National, for the traditional good fellowship of the Iceless.

Dear Sir:

The annual opening meeting of the Ardsley Curling Club will be held at the home of Russ Weston at 8:00 p.m. on the evening of October 18th. Russ lives at the corner of Langdon and Washington in Ardsley Park.

In prior years, it has been the custom to send a post-card with this letter asking that you advise the Club as to whether you expect to curl during the coming season.

Such a post-card is not being sent since we believe that the situation facing the club must be discussed in order that you can give us guidance and we in turn can advise St. Andrews of our plans for the coming season.

We have been advised by St. Andrews that because of extensive repairs to the curling rink and because of realignment of the expense chargeable to curling, that the total cost of curling to the Ardsley Club members will have to be \$72.00 for the coming season. To date our protests and those of the other clubs using the St. Andrews rink have produced no results and in consequence, your officers feel that they can make no decision on your behalf unless they can have the benefit of a full discussion on the part of the largest possible percentage of the membership.

You are strongly urged, therefore, to let nothing interfere with your attendance at this meeting and to insure a full attendance, only beer in cans trademarked "Keglined" will be served (commercial).

The opening meeting of the Club was held at the home of President R. B. Weston at 8:00 P.M., on the evening of October 18, 1949.

All of the officers were present and the total of all members present was 25.

Reading of the minutes of the previous meeting was dispensed with.

The report of Retiring Treasurer John H. Valentine indicated a beginning balance, October, 1948, of \$13.42, cash receipts of \$3,683.66, disbursements of \$3,272.14, and abalance remaining after the 1948-49 curling season of \$424.94. Mr. Valentine explained that this balance did not take into account monies due for expenditures at the Iceless Bonspiel at Manchester on October 1, 1949. On motion duly made, seconded and carried, the Treasurer's report was approved.

Mr. Stevens made a formal report for the Planning Committee whose chairman was not present, advising that they were attempting to secure information on the cost of building rinks.

President Weston made a report on the meeting of the Executive Committee of the Grand National Curling Club of America at Manchester on October 1, 1949. The minutes of this meeting are attached and will become a part of these minutes.

at which the Ardsley Curling Club was host on October 1st at Manchester. He especially commended Mr. Robert Warner for his activities as chairman of the Arrangements Committee. He reported an attendance of approximately 60 Curlers and 20 of their wives. The Committee reports expenditures of \$19.23 for medals for the Iceless and of \$292.90 paid to the Equinox House for the cocktail party at which Ardsley was host. Upon motion duly made, seconded and carried, it was agreed that Ardsley members who attended the Iceless would

assume \$75.75 of this expenditure pro-rated, and that the Treasurer would spread these charges against their individual accounts. The balance of \$216.15 is to be paid from the Curling Club treasury.

The Secretary read to the meeting a letter of thanks from the Grand National Curling Club of America and one from Mr. R. B. Iesser, Secretary of the Schenectady Curling Club thanking the Ardsley Curling Club for their hospitality.

Upon motion duly made, seconded and carried, the Ardsley Bowl is to be formally presented to the Grand National as their exclusive property with a letter setting forth the rules for its competition.

The main business of the evening was the opportunity for discussion, namely, the feeling on the part of the St. Andrews Golf Club that the charges for individual Curlers in the 1949-50 Curling Season would have to be \$60.00, plus federal tax of \$12.00. This increase from the 1948-49 dues of \$30.00 per member, plus \$6.00 tax, is made necessary by a review of the costs of curling made by the governors of the St. Andrews Golf Club. After much discussion of the matter, the following resolution was made, seconded and unanimously carried:

RESOLVED, that it is the sentiment of this club that its officers be empowered to arrange for an interview with the Curling Committee of the St. Andrews Golf Club at which meeting it is expected that the officers of the Mahopac Curling Club and the Caledonian Curling Club could be in attendance. The purpose of this meeting to be that of discussing, not only the question of the increased dues demanded, but a thorough investigation of means by which savings and that could be made in the operation of the St. Andrews Rink, more competion could be arranged for rather than less, in order that curling in the metropolitan New York area might be stimulated.

Special Meeting of the Ardsley Curling Club Held at the Home of Russell B. Weston on Monday Evening Nov. 21st.

Meeting called to order by President Weston at 8:15 P.M. Those present: Sothern, Hastings, Picard, Shaw, Robinson, Koehl, McAfee, Sutphen, Lanagan, Van Alstyne, Stevens, Gish, Fiske, Eddison, May, Weston, Warner, Von Bernuth, Hockmeyer, Kimbel, Thorndike.

The President read letter addressed to the manager of the Ardsley Curling Club asking whether we would desire to exchange curling buttons. The President appointed Mr. Fiske to reply to this letter and negotiate with Miss Coleman in exchange of buttons.

The President gave report of meeting with St. Andrews Committee extolling the virtues of Bill Kimbel and his negotiating ability. Messrs. Weston, Kimbel, and Graaskamp represented Ardsley. After general discussion, the St. Andrews group wished to make it quite clear that the Ardsley Curlers were more than welcome on the St. Andrews rink and that they were prepared to submit to the Board of Governors of the St. Andrews Club a request that the Ardsley Curling Club be charged \$1500. plus tax. The only addition to this figure might be that we could be called upon to subscribe for a slight deficiency.

A motion was made by Baron von Koehl and seconded by Junior Fiske that we accept this tentative proposal of St. Andrews of a flat fee of \$1500. plus tax.

A motion was duly made, seconded, and carried that associate members be charged \$7.50 for this year.

A motion was made, seconded, and carried that our membership be limited to thirty-five members.


A motion was made, seconded, and carried that the dues for 1949-50 season will be \$50. plus tax per person.

On a motion duly made, seconded and carried, it was decided to vote on the proposed twenty names for new members; each person voting from one to twenty - a name with no number or vote to be twenty-one points against and a-definite no or blackball vote fifty points against a person. The above-mentioned vote was duly taken and list turned over to Mr. May, Chairman of the Admissions Committee.

There being no further business, the meeting was adjourned.

Play for the Kimbel Plaque has been revived and an Ardsley Rink made up of Ad Hastings, skip, Fiske, Weston and Shaw defeated Caledonia (the 1948 holders) on Sunday 18 to 9.

They are now accepting challenges and anyone can form a rink and list it on the bulletin board at St. Andrews and they will then automatically meet the Plaque holders in their turn. The competition was conceived to make it possible for all curlers to compete in more matches than are normally scheduled - and medals are awarded to the Rink winning the greatest number of challenge matches. Line up a rink - you will enjoy it - and if you can defeat the Plaque holders, you will then be called on to defend your position with all challengers. A sheet of ice is reserved each Sunday afternoon for these matches.

We are also invited to send two Rinks to the Mitchell at Utica on January 26th, 27th, 28th and 29th.



December 21st, 1949

The Wilds match scheduled for December 20th between Ardsley #1 and Ardsley #2 has been postponed to December 29th.

Blanton Matches on December 20th were marked by brilliant curling and tumbling by Kinney and an international crisis precipated by an end in which each side used but seven stones through errors by the #3's who thought all rocks had been delivered. Since no known rule covers the situation, the end was called on the basis of its score at the moment the house was disturbed.

In a first round match, Wells defeated Sutphen 12 to 10.

In the Consolation, Gish eliminated Warner 11 to 7.

On Tuesday, December 27th, Hockmeyer will curl Wells in the second round of the Blanton and Shaw will face Sothern; Weston goes against Sutphen in the second round of the consolation.

The Ardsley Giant Killers - Luckett, skip, Wells #3, Staley #2 and Von Bernuth #1 took the measure of Ad Hastings' Kimbel Plaque defenders in a match on December 18th - 13 to 10. They are now in line to meet the next challenger and we hope they will have both good luck and good curling.

The Baron von Koehl (Al to you) has been forced to turn in his broom on doctor's orders. We are all damn sorry - but are glad to know he will retain an associate membership.



It has been found impossible to arrange a Rink for the Bonspiel at Detroit this week end.


Special Notice




The draw has not been completed and the Skips will announce to their rinks the time of the first matches.



Dick Wells, with a rink made up of Warner #3, Hockmeyer #2 and Wan Alystne #1 won the medal in a hard fought match with Ardsley's #2 rink skipped by Gish, with Thorndike at #3, Sothern at #2 and Graaskamp lead.

To reach the finals Dick had to face Caledonia #2 where he came from behind to win 13 to 10. He then met St. Andrews #2 and won 11 to 8 and the Country Club #2 where the score was 11 to 10.

Gish, first met Utica #1 and won 9 to 6. His next opponent was Winchester and in a 13 end match he won 9 to 8 (all three matches being played on that Friday night went to 13 ends because of ties). In the semi-finals he (Gish) defeated Caledonia #1 - 12 to 6.

The minutes of the Executive Committee Meeting of October 1, 1949 were read and approved.

The report of the Treasurer was read and upon motion duly made, seconded and carried, it was resolved that the Treasurer's report and accounts be accepted as approved by the Auditing Committee.

The following report of the Trophy Committee:

"The Trophy Committee, which is composed of Messrs. McMillan (chairman), Foster, Ten Eyck and Clarke has purchased, or is in the process of purchasing, pins for all of the Grand National events for the season 1949-1950. This includes the Tom Archibald Cup, the Utica Cup, the Douglas Medal, the Griffith Medal, the Allen Medal, the Mitchell Medal, the Country Club Cup, the Dykes Medal, the Brookline Cup, the Gordon Medal, the Emmett Medal, the Mohawk Trophy, the District Medals and the Gordon International Medal.

"In most cases we have not only purchased pins for the current year, but have purchased additional pins in order to save expenses in the year to follow.

"There was considerable difficulty in locating a number of the trophies. While technically perhaps the winning rink is entitled to take the trophy it wins with it, this presents a good deal of difficulty. A few, but far from all, of the clubs in the Grand National have 'homes' and in particular 'homes' in which cups may be held and displayed. This is not true, however, of a number of other clubs such as Caledonian, Mahopac, Ardsley and the like. A trophy is won by a rink - not by an individual. If the individual skip or some member of his rink carries away the trophy to his home, there is a great deal of difficulty in getting it back. This is particularly so if the individual happens to be away or dead.

"In view of the foregoing, the Trophy Committee would like to recommend that the cups and medals remain in the possession of the clubs at which they are played for, and further, that the clubs be held responsible for the safe-keeping of the cups and medals and for producing them each year. For example, this would result in the following being left at St. Andrew's: Tom Archibald Cap, Utica Cup, Douglas Medal and Griffith Medal. The Utica Club would be responsible for the Allen Medal, the Mitchell Medal and The Country Club Cup. Schenectady would be responsible for the Gordon Medal, Emmett Medal and the Mohawk. The Dykes Medal which, of course, is played for at different clubs each year, would be held at the club at which it was last played for - in the year 1950, St. Andrew's.

"Your Trophy Committee has had a great deal of difficulty in locating the various cups and medals, but we believe that they have all been found. The marking on all of them has been brought up to date - in several cases it was two or three years behind - up to the time of the playing of the January Bonspiel at Utica. In one or two cases new bases have had to be built because all available marking space was used up. Another thought which occurred to the Trophy Committee is that some of the medals should be redesigned, since, in the opinion of the committee, they are not particularly distinctive or good-looking. Your committee, of course, has no knowledge of the tradition behind some of these pins. The Mitchell, the Brookline, the Gordon, the Allen and some others appear to be distinctive and satisfactory. We question, however, certain others such as the Utica and the Emmett. In regard to the last named, it simply shows a picture of a man surrounded by a wreath. There is nothing whatever on it to indicate what the medal is - it might be almost anything. Most of the emblems have been purchased for the coming year. However, in the future, it might be well to re-examine all of the various pins and see which need redesigning. We recommend this with the full knowledge that the making of dies is an expensive operation which might entail considerable initial expense.

"The committee might also make one further recommendation and that is that the winning skips be held strictly responsible to the Trophy Committee for the exact spelling of the names of the men on their rinks. We have found that the secretary's records are often not too exact, and when it comes to marking the trophy, this has been an annoying handicap."

was read and upon motion duly made, seconded and carried, it was approved.

The Ardsley Curling Club offered to the Grand National Curling Club of America the Ardsley Bowl as a trophy for the golf competition at the Annual Iceless Bonspiel. An entry fee of \$1.00 is to be charged each contestant, said sum to go to the Grand National. Upon motion duly made, seconded and carried, it was resolved to accept the Ardsley Bowl, subject to Rules Committee approval.

The Secretary was directed to write a letter of thanks to the Ardsley-Curling Club for their-generous offer.

President Hastings appointed a committee composed of Mr. William Cuthbertson, Chairman, Mr. J. W. Calder and Mr. J. E. Steward, to direct future play for the Bell Medal.

Upon motion duly made, seconded and carried, it was resolved to pay to the Royal Caledonia Curling Club dues of five cents for each member of the Grand National Curling Club of America.

The following resolution was offered by the Utica Curling Club that the Dewar Trophy be presented for competition in the Annual Bonspiel at Utica:

RESOLUTION - Whereas John Dewar and Sons, Ltd. presented the Dewar Curling Trophy to the Grand National Curling Club of America in 1900 for competition between the member Clubs and Whereas the Utica Curling Club became the permanent possessor of the Dewar Curling Trophy in 1908 by virtue of having won it for the third time and

Whereas the Board of Directors of the Utica Curling Club desire that this trophy again be placed in annual competition. Be it resolved:

That the Dewar Trophy be hereby offered to the Grand National Curling Club of America to be placed in competition at the annual bonspiel at Utica, New York, under such terms and conditions as may be established from time to time by the Utica Curling Club and further that the annual winner of the Dewar Trophy be presented with suitable individual winners pins and further: that the custody of the Dewar Trophy shall remain with the Utica Curling Club.

Upon motion duly made, seconded and carried, the resolution was adopted. The Secretary was directed to write a letter of thanks to the Utica Curling Club for offering the Dewar Trophy.

The following resolution offered by the Utica Curling Club:

RESOLUTION - Be it resolved that the Grand National Curling Club of America be requested to annually supply for additional individual Mitchell winners pins to be identical to the present winners pins except for change in color and that such new pins be presented to the losers of the final match for the Mitchell Medal (runner-up) and further:

That the Utica Curling Club guarantee the payment for the four additional pins for the 1950 Contest.

upon motion duly made, seconded and carried, was adopted.

Upon motion duly made, seconded and carried, it was voted to designate the place for the next Annual Meeting, at the Executive Committee Meeting, which will be held in conjunction with the next Iceless Bonspiel.

Mr. Cuyler Stevens, Chairman of the Rules Committee, presented suggested revised new rules of play for the Grand National Curling Club of America. A copy of these suggested rules of play was given to every club representative present and the Secretary was directed to send a copy to those clubs not represented at the meeting. Upon motion duly made, seconded and carried, it was recommended that all clubs ratify these rules of play and that ratification by three-quarters of the member clubs would automatically place the new rules in effect. Upon motion duly made, seconded and carried, a vote of thanks was given to the Rules Committee for the excellent job they had done.

Upon motion duly made, seconded and carried, it was agreed that all cups and medals are to be left in possession of the host club, with each host club being responsible for their safekeeping and proper marking and engraving. The only exception to this resolution to be the Dykes Medal and the Brookline Trophy, which are to remain in the custody of the club of the winning rink, and it is to be the responsibility of the winning rink to see that the medal is properly engraved and marked before being placed in competition the next year.

On behalf of the St. Andrew's Golf Club, Mr. Ericsson submitted the following resolution:

That the Playland Cup be reinstituted as the consolation award in connection with the Utica Cup instead of the Tom Archibald Cap. The Playland Cup is the oldest curling trophy in connection with curling at St. Andrew's and for this reason it is felt it should be returned to competition.

Upon motion duly made, seconded and carried, it was voted to refer this resolution to the Trophy Committee with a request that they report at the Executive Committee Meeting at the Iceless Bonspiel.

Mr. Ericsson of St. Andrew's Golf Club requested an attempt be made to issue the schedule of the Grand National Curling Club events as early as May or June instead of October or November, as is now done. Upon motion duly made, seconded and carried, it was voted to refer this question to the Schedule Committee.

On behalf of the Farmington Curling Club, Mr. Sheperd offered a resolution, which was duly seconded, that the Farmington Curling Club request the opportunity of acting as host at the next Iceless Bonspiel which would be held at Manchester, Vt. The above resolution was unanimously carried.

The Vice-Chairman of the Gordon International Matches, which are to be held in Utica, stated that the invitations to fifteen Canadian Clubs had been issued and also the invitation to the Grand National Member Clubs. Each Canadian and Grand National Club would have two matches in the play.

Upon motion duly made, seconded and carried, it was voted to discuss at the next Executive Committee Meeting of the Grand National Curling Club the adoption of a policy of the Grand National to have the Schedule Committee designate two or more qualified member clubs to be hosts for the Gordon International Medal Matches when played in the United States. It is to be optional for any club designated to accept or reject such designation. Each club accepting such a designation shall determine how many rinks shall be invited to use its facilities.

It was also moved, seconded and carried that the Grand National Curling Club of America contribute up to \$150 to help defray the expenses of the Gordon International Matches.

The Secretary reported having received a communication from the Mid-West Curling Association extending an invitation to Member Clubs to participate in their Annual Bonspiel. Since this coincides with the Grand National Annual Meeting, the Secretary so advised, with regrets.

It was voted to adjourn at 7:10 P.M.

Stevens took his first match of the competition in handy style, winning from Fiske 15 to 3 in 10 ends. Wells reversed last Tuesday's results when he was on the wrong side of a large score, by defeating Kimbel 17 to 4 in 10 ends.

The final matches which will determine possession of the priceless mug signifying the cellar championship will be held on February 21st when Hastings meets Fiske; Wells meets Stevens and Kimbel meets Lucketta. It seems certain that all rinks should have purged themselves of their sins of omission and commission in their fourth round matches and that a bang-up finish should be expected.

Ardsley's rink at the Gordon-Emmett Bonspiel at Schenectady last weekend was enlivened both by Abbatoir May's absence and presence. He couldn't be in Schenectady for the first match so Boney Lydgate of Schenectady substituted. Fiske, skip, Hastings #3 and Stevens #2 lost to Utica #2 - 21 to 15 in 14 ends.

Their grief turned to joy almost immediately after the match when Western Union delivered Abbatoir's message:

"Sheridan rode to Winchester stop Courage stop Abbatoir riding to Schenectady"

As a result, they polished off St. Andrews (Mort Locke) 23 to 9 in 13 ends = Hastings skipping, Fiske at #3, Stevens at #2 and May at #1 - in their next match, with May living up to his promise to emulate Sheridan.

Their second and final Gordon match was against Utica #1, - Roy Ried, skip and Ward Murray at #3, plus two other sharpshooters. The score - Utica 14 Ardsley 10.

Festivities at Schenectady included the televising of some matches and a Union-Buffalo basketball game which Union won for the honor of Alumnus May and by the "French" and "marine" cheers of M. Fiske.

The annual meeting of the Grand National held during the Bonspiel resulted in the reelection of all officers, so Ardsley is again honored through the presidency held by "Ad" Hastings and the secretary and treasurership held by Eddie Fiske.

It is evident, however, that a prophet or a president is not as honored at home as he is abroad. Bill Kimbel, who brought the original charges against the eminent (in Grand National circles) Mr. Hastings, still insists that Addie is a perfidious and subversive influence - as follows:

"My determination to pursue action against Addison Hastings is in no way lessened by his evasive and honeyed words which you quoted in the last issue of your estimable publication. Those honeyed expressions about my curling abilities may make an impression on the inexperienced reader but I have reason to question their sincerity.

"This past Tuesday it was my pleasure (a figure of speech) to meet
Mr. Hastings in the Windeler Cup competition. At the beginning of the
match he extended his hand - as a presumably friendly gesture - and

six stones into the house (which I admit is better than the original Skip
at the garden of Eden did) and at the same time knocked all of ours out.

"Before I could regain my composure after this example of perfidy - I missed my two shots - whereupon he had the nerve to say, 'Hard luck, Bill', My rink never recovered. No further comment is necessary I am sure, except to remind you again of his obvious insincerity when he said 'May the best man win'.



District Medal


