One may not be giving much thought to curling in this record hot weather but the Grand National Curling Club of America is on the job, hot or cold.

The latest evidence of this is a letter from its president John Joy, informing us that this year's "Iceless Bonspiel" will be held at Stockbridge, Mass. Friday, Saturday, and Sunday, September 30, October 1st and 2nd with all participants staying at the famous old Red Lion Inn.

Stockbridge was chosen because of its being as centrally located as possible for all clubs, and since it is in the
beautiful Berkshires where at that time of year the foliage
should be at its height it seems an ideal selection.

The Red Lion Inn has arranged a special full American Plan rate of \$15.00 per day per person for room with private bath; \$13.00 daily per person for rooms with connecting bath.

The Stockbridge Golf Club has, to your secretary's personal knowledge, a fine 18 hole layout and has arranged a special greens fee of only \$2.50 per day for curlers. Furthermore on Saturday, October 1st, the day of the tournament, a simple luncheon will be served at the Golf Club, the cost of which will be part of the daily American Plan tariff quoted by the Red Lion.

Mark the dates on your calendar and plan to be one of what should be a large contingent to attend from the Ardsley Curling Club. Many members may wish to bring their wives and, as in the past, they will be a welcome addition to the party. Those wives who like to golf or appreciate beautiful scenic drives should enjoy it especially. Please check off the enclosed post card now if you expect to attend so we can notify as to the approximate number and we will make a recheck on about September 7th.

Meanwhile sharpen up your golf strokes, your gamesmanship, your fenders, your right elbows, your repartee or whatever else you contemplate exercising from September 30th thru October 2nd. Your "brithers" will be doin the same.

You are reminded that if you have any candidates for such vacancies as may exist in our membership for the coming year you would do well to record their candidacy now with the Membership Committee and have the prospect meet several members of that Committee and other Club members prior to our first fall meeting. 

PROCEDURE WITH RESPECT TO NEW MEMBERS ARDSLEY CURLING CLUB

- 1. The Membership Committee will consist of five active members, one of whom shall be designated Chairman, to be appointed by the President at the end of the Curling season.
- 2. This Committee will review all applications for new members so that these names can be presented with the Committee's recommendations at the first annual business meeting of the Club or at any subsequent meeting specifically called for the election of new members.
- 3. Applicants must be proposed and seconded by letter by active members and such letters must be in the hands of the Chairman of the Membership Committee prior to September 15th. Proposers' and seconders' letters will state applicant's previous curling experience (if any) and availability for regular weekly curling.
- 4. Associate members desiring to become "active members" will be automatically reinstated at any time providing there are sufficient vacancies, and will take precedence
 over any applicants on the approved waiting list. Should there be more associate members
 wishing reinstatement to active status than there are vacancies, then the associate members
 wishing reinstatement to active status will be voted upon in the same manner as hereinafter
 provided for new members.
- 5. The first official meeting of the Club at which new members will be voted upon shall be held on the third Tuesday of October. Notice to be sent to active members on or before the first of October.
- 6. Notice of this meeting will contain a list of new applicants to be voted upon with their respective sponsors and seconders. In the event an active member cannot attend the meeting, he may wail in his absentee ballot to the Chairman of the Membership Committee or give his proxy in writing to some other active member.

- 7. Ballot forms shall be presented at the meeting listing all candidates reviewed and recommended by the Membership Committee. Each member will then indicate his preference by placing the highest number opposite his first choice, etc. For example, if there are five applicants, the member's first choice would receive number five, second choice number four, and so on. The ballots will then be tallied and totalized and the candidate receiving the highest numerical total will be the first admitted.
 - 8. Members shall have the right to cross out an applicant's name, indicating disapproval. If three or more such "blackballs" appear against the same name, that applicant will be dropped from further consideration during the current curling season.
 - 9. All ballots will be secret and members are not required to sign their names, except that absentee votes or those given in proxy to another member will have to be signed by the active member involved in order to be bona fide.
 - 10. If, at any election, one or more applicants receives a total of votes which exceeds more than half of the maximum possible vote for one person and still fails to be elected, such name or names shall be considered a qualified waiting list. For example, if there are five applicants, and thirty active members participate in the election, the maximum possible vote for one applicant would be 150 (five times thirty). Assuming one vacancy, one applicant would be elected to membership. One or possibly two other applicants might receive more than 75 votes and would thus form a qualified waiting list. The applications for other unsuccessful candidates (who received a total of 75 or less votes in the above example) shall be returned to the Committee Chairman, but may be re-presented if another election is held during the current season.
 - ll. If additional vacancies occur during the season, and there is a qualified waiting list, the applicant on that list who had the highest vote shall be considered elected automatically. If there is no qualified list, the President may call a meeting specifi-

cally to hold an election, or designate that such an election shall take place at any other regular meeting. Notice of such meeting shall be mailed to all active members at least ten days prior to date of such meeting.

- 12. There will be no carry-over of a qualified waiting list at the end of the season.

 Names on such a list must be re-presented by sponsors and seconders, but consideration will be given to their having been on the list during the previous year.
- 13. Applications received after September 15th and at least two weeks prior to any later election during the season, as specified in Paragraph 2, will be eligible for consideration.
- 14. Sponsors should endeavor to have their applicants meet as many members of the Membership Committee and also of the general membership as possible. Sponsors should also make an effort to be present at the election meeting in order to properly present their applicant's names, etc.

The Mahopac Medal was won by Mahopac 2 (Mac Farlane) after a very close match with Schenectady (Ried), the final score being 11 - 10.



as quickly as possible, but not later than February 8th.



President Thorndike draws attention to the two new committees - 25th Anniversary and Long-Range Planning -- with the following comment:
