ALL AMERICAN REGULATIONS

1. Eligibility

- A. All clubs and members must be USWCA members.
- B. Clubs with both daytime and evening curling sessions, with at least 20 curlers in each, may have both a daytime and evening ALL AMERICAN curling event.
- C. A curler may participate in both events but may earn only one pin.
- D. A five member team is allowed, when necessary, in order to permit full participation of the club membership.

2. Procedure

- A. Four to seven entries should play a round robin to determine a winner.
- B. Games may be eight or ten ends at the discretion of the of the local event chairman. An extra end will be played to break a tie; one or two rocks per player will be thrown at the discretion of the local USWCA representative.
- C. The winning team must play a minimum of three games. A bye is considered a game and a win.

3. Rules of Play

- A. Current WCF Rules of Play shall apply with the following exceptions and additions:
 - 1. Forfeiture rules, timing and substitution of players shall be determined by the individual clubs.
 - 2. In bracketed eliminations, all initial pairings shall be done by drawing out of a hat.
 - 3. If possible, there should be no more than one club rated skip on a team in any game. Each clubs rating should be used to place the team members.
- 4. This event should not conflict with the USWCA National Women's Bonspiel and shall not be used as a playdown for the Bonspiel or as a consolation.
