Jinny Hill, 3 Brooms Chairman reported dates for 3 Brooms competition St. Andrews, Dec. 4th; Nutmeg, Feb 19th; Ardsley March 5th. Jo Owens, Nutmeg and Jackie Grant, St. Andrews are 3 Brooms Chairmen. Jinny suggested next year rotating clubs for first choice of dates for the scheduling of the competition.

Bonspiel chairman, Patterson reported that no invitations for bonspiels have arrived. The Empire State will be played at St. Andrews, Jan. 19, 20. and 21. Nutmeg will have a Ladies Bonspiel 12, 13, 14th.

Our Board voted not to have our Ladies Bonspiel this year because of the Empire State and the Nutmeg Ladies Bonspiel. We will have one in 1983. This year we will make plans for a couple of friendlies. Next year we will be celebrating the 50th anniv. of the Ardsley Club.

The minutes of the Oct. 5th meeting were read and approved with the addition that as to when and how the All-American competition will be played is still undecided.

Bobbie Patterson reported that the missing names on the Wells-Wicks trophy were for the year 1977-1978.

The Treasurer's report is unchanged from last month. The Board decided to keep the contingency amount at five dollars.

Bobbie Patterson announced she had received an invitation for the Broomstone Bonspiel at Wellsley on Jan. 26th-28th. Invitations for all the ladies bonspiels will be posted on the ladies bulletin board. It was felt that we should have a team for the Empire and the Nutmeg.

Board Meeting

Monday, Jan. 4th, 1982

The meeting took place at 10:00 A.M. at the home of Marilyn Eager. Members present were; Eager, Hill, Meszaros, Fletcher, Nolan, Wells, Patterson, Ficalora, Noble Garred and Heath. The minutes were read and approved as corrected. The treasurer reported a balance of \$109.33 in the checking acc't and \$572.71 in savings totaling \$682.04. Three contingencies are unpaid.

Jean MacIntosh reported a new curler, Gerry Carpenter. Jane Wells knows of a prospective curler with some curling experience. It was decided to wait until the Feb. competition to invite her to join. Marilyn announced that there would be an Open House on March 20th to which we will invite everyone we had invited last year, as it is important to keep the momentum going in encouraging prospective members.

Vanda was congratulated on the clubhouse Christmas decorations and also Jinny for the ilex balls. The decorations are to be taken down after next Wednesday's curling. The carnations will be left in the three baskets. Vanda passed around an ad for standing lamps so members could express their preference. Alice offered a brass standing lamp that only needs a shade. A discussion followed on the possibility of having two lamps. Jean will ask Jim Welch to look into putting a track lamp over the bulletin board.

Alice reported receiving a questionnaire regarding a senior women's bonspiel. We had previously said yes to this. It was agreed that the date we would prefer for this event in 1983 should be in February or March. Before the Utica competition next month there is to be a representatives meeting which means that one of the four members of our team would have to get to Utica for a four o'clock meeting on Monday and an all day meeting on Tuesday before the start of the competition on Wednesday. On the agenda will be voting on per capita dues raise and citizenship eligibility for participants as well as changes in the constitution. So far we have received no information regarding the meet itself. Marilyn volunteered to go early as our representative. The board felt that the club should subsidize in part anyway a representative's extra expenses. It was decided that we should find out what other clubs do before making a motion on this matter.

Jinny Hill said she had received a report on the Three Brooms match at St. Andrew's from Jackie Grant. This will be incorporated with these minutes. The next competition will be at Nutmeg on February 19. The sign-up sheet will be posted this Wed. New curlers can play in the friendlies.

There is no report from the Thursday Night curlers.

Bobbie reported that no new invitations had come in. No one so far has signed up for Winchester in March. There will be an Albany bonspiel on Feb. 22nd. Niceclub and nice bonspiel. We would like to send a rink.

Marilyn reminded the board that according to our by-laws we should have two special events each year. It was decided to do a friendly

In regard to the Thursday Night Curling Marilyn said Carol was doing a great job, and ~~they~~ are working up to having 2 sheets going. They would like a friendly game some night with the day curlers and would serve dessert and coffee. This is to be arranged through Bobbie.

There is no report on membership. Marilyn said she would try again to contact Lillian Kingery having had no call back earlier.

Marilyn mentioned that it was advisable ~~not~~ to cut games <sup>short</sup> only with care as most players look forward to a complete 8 end match.

Fran said she would put up the sign-up sheet for the All-American early.

Board Meeting

Monday, March 1st, 1982

The regular monthly meeting took place at the home of Marilyn Eager at 10:00 A.M.

Members present were Eager, Ficalora, MacIntosh, Nolan, Garred, Doonan, Fletcher, Patterson, Noble, Heath and Hill.

The minutes were read and approved.

The treasurer reported a balance of \$182. 51 in the checking account, \$572.71 in the savings account which totals \$755.22.

Our Friendly scheduled for February 5th had to be cancelled because of the ice. We were unable to reschedule it.

It was found at the USWCA meeting in Utica that the other clubs do pay the entire expense of their representatives attending the meeting. The board voted that Marilyn be reimbursed for her extra expenses of travel, room and meals in order to attend the meeting. Policy on this for the future will be taken up at a later date.

Marilyn gave a report on the meeting at which she was impressed by the enthusiasm of the representatives. The 4 o'clock meeting was an opportunity to discuss problems. There were complaints about the playdowns. Ours did not have to be done as it was and we may plan our own as long as the area coordinator knows in advance. It was suggested that conflicting bonspiels be worked out by the sectional clubs on a rotational basis. Playdowns for the USWCA bonspiel also the championship should be localized for our section: Nutmeg, Ardsley and St. Andrews. This board should vote on that. At the annual all day meeting it was pointed out that proxies should be sent in anyway as an attending representative can withdraw it and vote. It was voted that rinks for the Scot's tours must travel on a BS passport but for the US championship no decision was arrived at. A bonspiel for curlers over Fifty-five will be held. Chicago will have the first, sixteen rinks only. Next year the USWCA bonspiel will be held at the Mayfield Club in Cleveland and the USWCA championship at Grafton, No. Dak.

Jean MacIntosh made a motion that we send \$46 again using the same ad to support the Grafton event. It was so voted, the money to be sent in the fall.

Alice read a letter from Ann Winslow, area coordinator for the East, asking our opinion on changes for next year regarding playdowns suggesting that we keep divisions but divide them geographically. We will advise Ann that we can host the round robin playdown in December on Mon. the 6th, Tues. the 7th and the 8th if necessary. ~~There will be five teams.~~

Bobbie reported that a rink was going to Plainfield on March 15th in response to an invitation from them. There was discussion on whether it would be preferable for members to sign up as a rink next year instead of as individuals. This will be left up to the curling committee.

Vanda will buy a new lamp as it was not possible to find a shade for the one Alice offered. Decorations of white flowers and green

ribbons for both the Three Brooms and the March 20th Open House. were decided on. The silver and cabinets are to be cleaned on Wednesday, volunteers to help Vanda. Jean will buy the 2 qt. saucepan. Anita offered the use of her ~~her~~ large heavy pot over the curling season.

Fran asked the board if they would like to consider the method used by the men of picking the skips and letting them pick their teams. No decision was made.
