Next comes practice Dec. 6 for the 2 Brooms. The All American will begin in January. There will be time for another competition afterwards. She would like pins for additional events. Flame and Ice Breaker pins are needed. Shirley suggested USWCA old pins can be gotten cheaply. She will order. Ardsley Curling Club treasury will be asked to pay for all.

#### ARDWICKS BOARD MEETING - ARDSLEY WARM ROOM - FEBRUARY 27, 1995

The meeting was called to order by President Nadja McKay at 12;10 p.m. Present were Jean Glus, Jean MacIntosh, Margaret Guiry, Mary Jean Keenan, Betty Steinemann and Shirley Bruce.

Secretary - In the absence of the Secretary and the absence of last meeting's minutes, reading of minutes waived to next meeting.

Treasurer -The Treasurer reported a balance of \$2,126.83 and wonder of wonders a balance of \$43.50 in the bonspiel account.

Empire State - Nadja expressed the thanks of the whole club to the two Jeans (Glus & MacIntosh) for taking on and then pulling us all through the Empire State Bonspiel, with a thank you to everyone who helped. Mary Jean expressed a special thank you to Vanda Ficalora for hosting the opening party.

Compressor - Nadja explained the state of the Ardsley Curling Club treasury - or lack thereof - that bonds would be offered to members and a general assessment would have to be levied, with the cost of the newly installed compressor to be upwards of \$20,000.00. In view of this, a motion was passed to donate \$1,000.00 to Ardsley Curling Club to help defray compressor charges.

Two Brooms - In Lillie's absence it was reported that the day ladies won one game and lost two and the trophy remained at Nutmeg.

Curling Calendar - Mary Jean noted that there would be three weeks of curling after the end of the Wells-Wicks and this would be a Junior Skips event. The first 2 weeks would be curled on Wednesdays and the 3rd week would be curled on Thursday April 6th.. Margaret Guiry noted that the night ladies have curled 2 sessions of the All-American with one more to finish. The Pull-the-Plug party is set for Saturday, April 8th.

USWCA -Shirley reported that the dues as of the 1995-96 season will be raised from \$3.00 to \$4.00. It is at least 15 years since they were set at \$3.00. The USWCA over the last several years, has contributed money to USCA projects and has been running a \$1500 deficit for the last two years.
