As both former clubs were co-hosts of the Empire State Bonspiel, we realize this does present a new wrinkle.

We, as the Ardwicks, want to be co-hosts of the Empire State Bonspiel. If this is agreeable to Schenectady and Utica, we need you to decide how many teams you will want from us at the Utica Empire State Bonspiel in January 1990 - i.e. - 2 as a co-host, 4 for this initial year, or perhaps 3. Our proposal is:

- 1. The Ardwicks host the 1991 Empire State Bonspiel as it would have been Ardsley's turn under our former set-up.
- 2. We retain the Empire State Bonspiel as a four event bonspiel, using the Clarke, the Siebert, and the Ardsley Duck and Duckling.
- 3. At the 1990 reps meeting during the Bonspiel, be prepared to discuss and formulate a rotation of primary hosts, etc. that will be agreeable to Utica, Schenectady and Ardwicks.


