A 3-member team represented the Ardwick's at the 16-team, 2nd annual Bay State Bonspiel held at Broomstones Curling Club. The Bay State is a ladies 'spiel held annually and rotates between the three host clubs of TCC, Broomstones and Winchester. The team of Shirley Bruce, S; Mary Jean Keenan, 3; Kathy Mudge, 2; and Elizabeth Schmidt-Scheuber of Broomstones had a grand time off the ice - in spite of snow storms, and on the ice managed to win the 4th event.

USWCA NATIONAL BONSPIEL

An Ardwick's team ventured into the USWCA National Bonspiel, held Feb. 13-17 in Schenectady. This is a 32-team 'spiel held yearly, rotating location between the Eastern, Central, Wisconsin and Western areas and this year 10 states were represented. All games were 10 ends.

The team of Shirley Bruce, S; Bobbie Patterson, 3; Marcella Hanlon, 2; and Molly Babcock, 1; truly outdid themselves and curled beyond their expectations to win the 2nd event. They only lost one game, by one rock, and that was to Carla Casper of Green Bay, Wisconsin. Carla has won the U.S. Ladies Championship, has curled in the Ladies World Championship and in the Olympics.

The teams beaten by the Ardwick's were - Ak-Sar-Ben, Omaha, NB; Skokie Thistles, Glencoe, IL; Albany Ladies, Albany NY; North Shore, Glenview IL and, in the finals, with an extra end, the St. Paul Bonnies, St. Paul MN.

Needless to say it was a very exciting 'spiel for all and the only disappointment was the inability to 'bring home' the trophy. It needs a new box but will be shipped out shortly and very proudly displayed for one year.

Four area women, representing the Ardwick's from the Ardsley Curling Club, defeated a St. Paul, MN, team to capture the second event Indian Hill Trophy at the 42nd United States Women's Curling Association National Bonspiel held recently at the Schenectady Curling Club, Schenectady, NY. The rink, skipped by ~~skipped by~~ Shirley Bruce and including Bobbie Patterson, third, Marcella Hanlon, second and Molly Babcock, lead, was among 32 teams from 10 states participating in the competition. The local curlers defeated teams from ^{Omaha, Neb.} Skokie, IL, Albany, NY, and North Shore, IL, before overcoming St. Paul, MN in the finals.
