ARDWICKS GENERAL MEETING

January 26, 2012

President Kris Liddle opened the meeting, which was held at the Ardsley Country Club. at 12:50 pm. There were 12 women present including the President, the 2 Daytime Curling Vice Presidents, the Secretary and the Treasurer.

It was noted there is over \$3,400 in the Treasury. Mieko Takiguchi made a motion that we buy a quarter page ad in the McKay Douglas journal at a cost of \$250. Motion was seconded and, after discussion, was unanimously passed. Sarah Mermer will be asked to design the layout of the ad. We assume that the Ardwick's will again be able to insert a full page letter stating our congratulations for the event in the journal, as has been done in the past. Kris will compose such a letter and submit it.

The fire that destroyed the Norfolk Curling Club was discussed. Wezie Corey made a motion that we support that club with a donation from our treasury of \$500. Motion was seconded and unanimously passed.

The President noted that her term of office expires at the end of this curling season. Some discussion was held on the changes that have occurred over the past year and one half. The ladies bathroom has been painted. The screening off of part of the downstairs has not been accomplished. It is thought that perhaps a better solution than a cloth curtain might be a folding screen. This needs to be pursued next year. A Nominating Committee has been formed. Serving on it will be Wezie Corey, Pippa Broadhurst and Nicole Zahour.

The first half of this season's Two Brooms was held at Nutmeg. We are hosting the second half next Thursday morning. Plans were firmed for our members bringing items for lunch, which will be served in the warm room. Wezie and Kris will decorate the day before. It was noted Alison Bankes has a corporate event that Thursday afternoon.

Pippa said that the supply of Ardwick pins is low in the place where they are usually kept. Kris will check with Sarah Mermer to see if there are others elsewhere or if they need to be reordered. Pippa also noted that pins will be needed for the Wells Wicks and MacIntosh events (gold and silver - 8 each). Kris will follow through.

There being no other business, the meeting was adjourned at 1:10 pm.

The women's curling association at Ardsley Curling Club.

The purpose of Ardwick's is to support women's curling leagues, bonspiels, and the United States Women's Curling Association, to inform women of upcoming curling events, and to encourage membership participation. The group focuses on helping to improve the curling experience for women through instruction in rules and play, and assisting new curlers in the development of their skills.

The name, Ardwick's, came as a result of the joining of the Westchester Wicks (founded in 1950 at St. Andrews) and the Ardsley Ladies' Curlers (founded 1966 at Ardsley) in 1989. The new name combined parts of both names as "Ardwick's".

The joint organization has over the years, contributed in many ways to the advancement of women's curling at Ardsley. The Tuesday night league, and Thursday morning leagues provide a pool of volunteers who work together on ACC house events and the several men's bonspiels. I think this has been said in your first sentence (and bring along new curlers.) NOT NEEDED

Women at Ardsley have hosted and taken part in the Empire State Bonspiel when held at Ardsley, and have faithfully sent two teams to the event sponsored by other clubs. They have hosted visiting members of the Scots and Canadian tours and annually take part in the All American event sponsored by the United States Women's Curling Association.

Ardwick's has painted the ladies room, provided curtains and table clothes for the club from the money collected as dues from members. It has donated money to the club for special maintenance projects. Ardwick's also provides a pool of volunteers to support ACC in house events.

Hi: Fortunately, the job has been relatively easy. Most of the women curlers are supportive of the work of Ardwick's, and are interested in doing things that need to be done. Don't carry tales back and forth, and watch out for those who tend to be divisive, was my rule of thumb. I let the Tues. night and Thursday morning chairmen do their job, and congratulated them on the work they did. They were in charge, and worked in the best way they could. I think they were more on the firing line than I was.

Otherwise, the major responsibilities were organizing the Two Brooms, and there was a lot of help available, and we painted the ladies room (Alison and Barbara). Alison has been a great help on organizing the food for the men's curling events that we cooked as a volunteer effort for the Club. She is on the Board of the Club and in touch with the goings on there.

We should look upon curling as a game, sometimes we lose, sometimes we win. We do not sacrifice the losers to the gods. Lastly, it is important to support new curlers and encourage them in their efforts to learn.

The only major problem left was discovering how to provide privacy in the changing room. Goef Brodhurst suggested a curtain which could be pushed back out of the way when not in use. However, the ceiling in the room is very uneven, and finding a solution has been difficult. Some have suggested screens that could be folded away, but a formal decision was never made.

Next year, we are responsible for hosting the evening event of the Two Brooms at Ardsley. The timing would be arranged with Nutmeg, and Ardwick's would cook. There are many willing hands. It would be held on a Tuesday night. We need to encourage stronger curlers to participate to bring back the trophy to Ardsley. The morning event would be held at Nutmeg.

Lastly, as president you should encourage curlers to participate in Women's curling events through your USWCA rep. (Nancy), and participate yourself when you can.

If there are problems to solve or if a request comes from an Ardwick to solve a curling problem or if there is a need to change the Constitution and Bylaws. ARDWICKS EXECUTIVE BOARD MEETING
April 22, 2012

The meeting was, held at Harpers Restaurant in Dobbs Ferry..

Present were Melissa Dominguez, Alison Bankes, Nancy Clancy, Marion Cowles and Dolores Redding.

President Dominguez opened the meeting at 11:00 am.

Webpage - Melissa will propose to the Ardsley Curling Club Board that there be an Ardwicks page on the website. The purpose is to provide easy access to useful information. This would include listing our officers, our Constitution and Bylaws, Secretary's minutes of meetings, upcoming women's bonspiels and any other pertinent information to share about the Ardwicks with the curling club or any others who may find the information of interest.

Treasurer - Alison reported that as of March 31, 2012 there is a balance of \$2,603.61 in our checking account. Income comes from dues and profits from the Empire State when we host.

It was noted that we have a commitment to pay for some travel expenses (room or plane) for one meeting annually our USWCA representative attends. Nancy had not been reimbursed this past season.

Cost of pins and engraving is paid for by the curling club.

We still plan to use some of these funds for the benefit of the curling club, possibly constructing some sort of privacy division (curtain or screen) downstairs to facilitate changing (we need to find out what the level of need there is for this, or whether the existing area in the bathroom is sufficient). The purchase of a new stove was also discussed. Possibly we would contribute funds towards the dehumidifier, which the board is expected to purchase. All options will be considered, and a proposal will be made to the ACC board for the upcoming season (2012-3).

Two Brooms - Nutmeg will be coming to Ardsley on a Tuesday night and we will go there a week day morning. A chair needs to be appointed to coordinate with Nutmeg and recruit teams. We discussed whether to form teams using only curlers from our women's leagues or consider opening it up to all women. Discussion to be continued with the Tuesday and Thursday chairs.

Mission Statement - Melissa said that it is her goal to make the Ardwicks more visible to all women of the Ardsley Curling Club. It is important to share information and to communicate opportunities for participating in bonspiels, in house events and sessions, to explain our support of the USWCA and the value of a women's organization and to welcome all women of the Ardsley Curling Club and generate interest in joining the Ardwicks

Plans to achieve this include communicating with all women members and having an Ardwicks webpage to make all of this information easily available to all; encouraging bonspiel attendance by providing a schedule and contact information and facilitating the formation of teams.

And also use the All American to reach out to the 40% of women who do not curl on Tue eve or Thu morning, by inviting them to join us for that session. To be discussed further with the USWCA rep and the Tuesday and Thursday chairs.
